
# CIP Priorities and Existing CIP Process

- Annual Council Review of the CIP Priorities
  - Revised priorities adopted through resolution.
- Next Fiscal Year's CIP Developed and Adopted in Parallel with the Overall Budget
- Future Year's Projects and CIP Document
  - Staff Development March-April
  - Council Review May
  - Finalized June


